The WISE Award Program recognizes three outstanding Federal women scientists and engineers. Each agency is limited to one nomination per category. There is the WISE Award for Scientific Achievement, the WISE Award for Engineering Achievement, and the WISE Lifetime Achievement Award. When an individual, agency, or organization that has made exceptional accomplishments consistent with the goals and objectives of WISE is brought to our attention, a special panel reviews those accomplishments and makes the decision as to whether an award is appropriate.

Objective:

- To recognize a specific or special scientific or engineering/technical contribution by a woman scientist in the Federal service, and
- To recognize a specific contribution made by a woman scientist in the Federal service toward encouraging young girls and women to pursue science or engineering careers, or to enhance employment, promotional or developmental opportunities for women scientists in their fields.

Granting of the Awards:

- The award is granted in the form of a plaque. Each award is presented at the annual awards luncheon on the first day of the WISE National Training and Development Program in the presence of all attendees, guests, and the media.
- Award recipients are also recognized at a reception held in their honor on the same day.

Eligibility Requirements:

- These awards are directed to Federally employed (both civilian and non-civilian) women scientists and engineers.

- Each Agency or Major Department of Government may only submit one nomination for each of the three awards.
- Each nomination must include an original and ten (10) copies of the following:
- The complete "Nomination Form"
- A statement of no more than two pages summarizing the nominee's achievement contributions, and initiative regarding girls and/or women.
- A copy of the nominee's resume, SF-171, and curriculum vitae which should include such things as a listing of publications, patents, etc.

Please print clearly or type the information below. If your nominee(s) is selected as the winner of the award for which she is nominated, a 5 x 7 photograph will be needed for the Awards Program. The agency is to provide transportation and per diem for award recipients to attend the awards luncheon and evening reception.

NAWCAD HRO AD 7.3 will ensure that nominations are reviewed/endorsed within NAVAIRSYSCOM HQ and forwarded to the Department of Navy Awards Review Plan.
